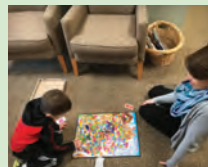
- ✓ Prevention education programs reached nearly **7,200** children.

- 1984:** Volunteers gather to provide group treatment for children and families affected by child sexual abuse
- 1988:** Family Support Line incorporates as a nonprofit
- 1990:** Began prevention work through personal safety programs to school children, teachers and parents.
- 1997:** Launched the Therapy Network program serving individual therapy to survivors and families
- 2003:** Named Nonprofit/Charitable Organization of the Year by the Delaware County Chamber of Commerce
- 2004:** Initiated professional training programs with Widener University.
- 2016:** Delaware County Children's Advocacy Center receives full accreditation from National Children's Alliance
- 2016:** Held our 50th consecutive Community Group session

 Doubling the current available space for interviews with children in need of help.

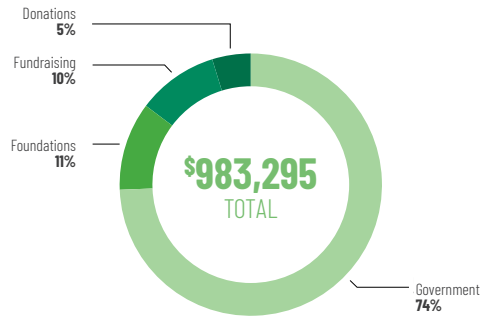
 **SECURITY**

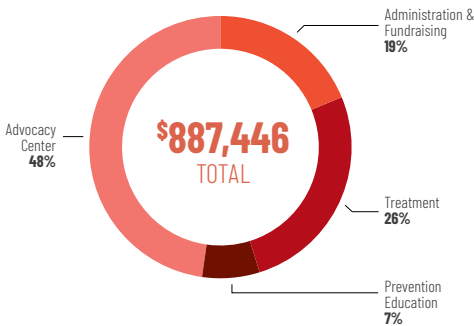
